Hafla 2022 Cruise will be a five-night cruise leaving Miami on October 31 and returning to Miami on November 5, 2022. Our ship, Celebrity Summit's itinerary is the following:

- Day 4 - Thursday, November 3; George Town, Grand Cayman Tendered 10:00 am to 6:00 pm
- Day 5 - Friday, November 4; At Sea
- Day 6 - Saturday, November 5; Arrives Miami at 7:00 am

### Staterooms

The Hafla committee has requested a block of staterooms in each stateroom category. Each cabin will accommodate two guests—the prices are quoted per person and based on double occupancy. If you want a third or fourth person in the same stateroom, don't hesitate to contact our representative, Roland, at [haflareunion@sevensesevents.com](mailto:haflareunion@sevensesevents.com) for help.

Hafla is required to meet goals for payment throughout a period. The first payment for us is November 21; therefore, we must start booking rooms immediately. The cruise line will automatically assign staterooms as we purchase them. We have requested Celebrity to keep our Hafla group close to one another. If we fill up our block of staterooms promptly, we will be able to accomplish this timing requirement.

Keep in mind, if you wait too long before booking a room, the rates may change if demand rises, and we have not secured the rooms. For example, if people do not book soon, we will be required to return some of the rooms to the cruise line as we will have to pay for them without compensation. Later, you may want to reserve a stateroom; we may no longer have it available in our block of staterooms. At this point, we must renegotiate the package rate for additional people.

The Cruise Line reserves the right to impose a fuel supplement on all guests if West Texas Intermediate fuel price exceeds \$65.00 per barrel. The fuel supplement for 1st and 2nd person in a stateroom would be no more than \$10.00 per person per day, to a maximum of \$140.00 for the entire Cruise, and additional people in the same stateroom would be no more than \$5.00 per person per day, to a maximum of \$70.00 for the entire Cruise.

### Trip Insurance and Force Majeure

Force Majeure is part of the contract we signed with Celebrity Cruise Line.

*If Cruise Line is forced to cancel the Cruise due to Acts of God, breakdown of the Vessel, hostilities, blockades, labor conflicts, strikes aboard or ashore, restraint of rulers or princes, war, fire, collision, directions of underwriters, arrest, order or restraint by governmental authorities or others (including due to the actions of port officials or government-imposed travel restrictions), acts of terrorism, civil commotions, embargo, weather conditions or considerations of safety of the Vessel (of which the Master shall be the sole judge), foundering of the Vessel or breakdowns of or damage to its hull, machinery and fittings, inability to secure or failure of supplies including fuel, requisition of the Vessel, disease, epidemic or pandemic, or other circumstances beyond the Cruise Line's control (including but not limited to a change in Cruise Line's fleet deployment caused by any of the aforementioned events) (collectively such causes shall be referred to as "Force Majeure Events"), the sole liability of Cruise Line, and/or the Vessel, shall be for a refund of all monies theretofore paid by the Purchaser to Cruise Line hereunder for all obligations not then performed or for which the Purchaser has not had benefit. For the avoidance of doubt, under no circumstances will Cruise Line be obligated to refund any cancellation charges incurred pursuant to Section 17 above (or under a prior agreement between the Parties) prior to Cruise Line's cancellation of the Cruise.*
